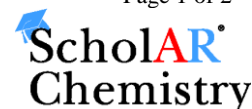

Section 4: First Aid Measures*Always seek professional medical attention after first aid measures are provided.***Eyes:** Immediately flush eyes with excess water for 15 minutes, lifting lower and upper eyelids occasionally.**Skin:** Immediately flush skin with excess water for 15 minutes while removing contaminated clothing.**Ingestion:** Call Poison Control immediately. Rinse mouth with cold water. Give victim 1-2 cups of water or milk to drink. Induce vomiting immediately.**Inhalation:** Remove to fresh air. If not breathing, give artificial respiration.**Section 5: Fire Fighting Measures**Oxidizing agent. When heated to decomposition, emits acid fumes of NO_x.**Protective equipment and precautions for firefighters:** Use foam or dry chemical to extinguish fire.

Firefighters should wear full fire fighting turn-out gear and respiratory protection (SCBA). Cool container with water spray. Material is not sensitive to mechanical impact or static discharge.

Section 7: Handling and Storage**Yellow****Handling:** Use with adequate ventilation and do not breathe dust or vapor. Avoid contact with skins, eyes, or clothing. Wash hands thoroughly after handling.**Storage:** Store in Oxidizer Storage Area [Yellow Storage] with other oxidizers and away from any combustible materials. Store in a cool, dry, well-ventilated, locked store room away from incompatible materials.**Section 8: Exposure Controls / Personal Protection**

Use ventilation to keep airborne concentrations below exposure limits. Have approved eyewash facility, safety shower, and fire extinguishers readily available.
